- Established the **Hong Kong Green Label Scheme (HKGLS)** in 2000 to certify products that are environmentally preferable according to ISO 14021





Types of Environmental Labels

ISO established guiding principles for the development and use of environmental labels and declarations


Type I Guidance for leadership certification (ISO 14024)
Multiple criteria, life cycle considerations



Type II Guidance for self-declared claims (ISO 14021)
Self-declaration / Claims by manufacturers




Type III Guidance for information (ISO 14025)
Life cycle analysis-based; self-declaration verified by independent third parties



Recycling in Hong Kong

- Waste recovery rate has been decreased from about 50% to 30% since 2010.
- Government announced “Waste Blueprint for Hong Kong 2035” in February 2021 which setting out the vision of "Waste Reduction·Resources Circulation·Zero Landfill”.
- Disposal of municipal solid waste-charging scheme will start in 2023.
- Government has provided funds to support recycling value added chain covering processing, product improvement, commercialization, marketing and sales of recycled products made from recyclables.



More products with recycled contents are found in packaging/container/tableware/construction materials



How could consumers verify the claims of recycled products?

What is the percentage of recycled content?

Is there any testing report to confirm the content?

Are the recycled materials collected from post-consumer or pre-consumer waste?

Is there any 3rd party to verify the claim?

Verification Processes

- After mixing recycled materials with new materials, they cannot be easily distinguished from final products

- Verify the source and mixing ratio of pre- and post-consumer recycled materials process within the supply chain through document review and onsite audit
